



A Resolution to hire an Assistant Recreation Director for the Recreation Department.


Whereas, Tammy Sinn, Williamsburg Recreation Director, requested to hire an Assistant for the Recreation Department.


Be it resolved by the Williamsburg City Council;

A Resolution to hire a Custodian/Light Maintenance person for the Recreation Department.


Whereas, Tammy Sinn, Williamsburg Recreation Director, requested to hire a Custodian/Light Maintenance employee.


Be it resolved by the Williamsburg City Council;
