6. Motion by Phillips seconded by Kirkpatrick to close the public hearing at 8:30 p.m. All ayes. Motion carried.

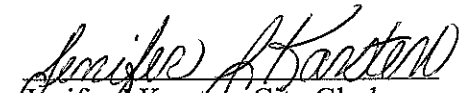

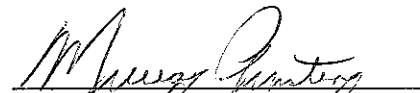
